Itineraries: The itineraries for 2014 are scheduled on the websites [www.ciaobellatours.com.au](http://www.ciaobellatours.com.au). Although we do our best to adhere to the schedules and experiences listed, each itinerary is subject to change for numerous reasons beyond our control.

Tour Costs: Tour dates and costs for 2014 in twin share accommodation with bathroom facilities per bedroom are:

Very limited single accommodation is available at a supplementary cost.

**Accommodation** is provided for Tour A in two 5\* hotels, two 4\*, and one 3\* in the mountains for 2 nights; for Tour B in three 4\* hotels; at a central 4\* hotel in Firenze and at an "agriturismo" elegant country villa for Tour C in Toscana; three 4\* hotels for Tour D; for Tour E one 5\* hotel and a 4\* ex-castle in the countryside; Tour F two 4\* hotels. There is a swimming pool in some or all accommodation at Tour A, C, and E country accommodation.

Tour Includes: All accommodation (9 nights); 9 breakfasts, lunches and dinners (as outlined in itinerary); wine at lunch and dinner at meals and at wine tastings (as determined by Ciao Bella Tours); all land transport (as outlined) which may include minibus with driver, private car, occasional local public transport, or use of taxi; entrance fees to museums and sites identified; an accompanying escort; documentation regarding itinerary and sites to be visited. Tour C includes 10 lunches (not 9). Tour A provides 13 nights accommodation with one free day, allowing for independent travel between the two islands.

Tour does not include: Airfares, taxes, passport fees, travel insurance, visas (if applicable), items of a personal nature, telephone expenses, personal spending money, gratuities, additional beverages (other than wine at meals and aperitivi as determined by Ciao Bella Tours), luggage in excess of 20kg, portorage, travel between islands on Tour D..

Payment and cancellation: In order to reserve a place in a tour a non-refundable deposit of \$AUD 550 is required at time of booking. Full payment must be made 70 days before commencement of the scheduled tour. In the event of a client cancelling a confirmed tour booking, the following cancellation charges apply:

- 71 days or more prior to commencement of tour = loss of deposit
- 30 - 70 days prior to commencement of tour = 20% of total price
- 08 – 29 days prior to commencement of tour = 35% of total price
- 01 - 07 days prior to commencement of tour = 50% of total price
- on day of commencement of tour, or later= 100% of total price

*Ciao Bella Tours Pty Ltd* reserves the right to cancel tours and refund all fees paid (including deposits) if minimum numbers (4 per tour) are not met, not less than 29 days prior to the scheduled tour.

Price variation: Due to international currency fluctuations it may be necessary to increase costs of tours if the exchange rate varies between the \$AUD and the EURO more than 8% from the exchange rate applying at 30 March 2013. In this case, costs will be applied to prices quoted on the website. Variations will not be charged after full payment has been received by *Ciao Bella Tours Pty Ltd*.

Travel Insurance: Travel insurance is not included in the tour cost. Travel insurance is a mandatory requirement for acceptance on a *Ciao Bella Tours Pty Ltd* experience, and must include provision for emergency evacuation from Italy if required, medical treatment in Italy and/or Australia as appropriate, payment of hospital bills and repatriation back to Australia if necessary, travel delays, lost baggage, lost/stolen money. It is strongly recommended that insurance be taken out to protect yourself against unforeseen events that may occur, including but not limited to, cancellation fees, airfares and/ or land costs, overseas medical expenses. Should you have to cancel or interrupt your tour because of illness, injury or death to you or a family member, trip-cancellation insurance may protect most of your deposits and payments for both air and land costs. It is highly recommended that you also purchase Trip-Cancellation Insurance.

Withdrawal from the tour. *Ciao Bella Tours Pty Ltd* will not accept liability for any expenses incurred by tour participants who have to withdraw from a tour for medical or any other reasons. Tour participants will also be required to meet any personal or medical expenses incurred.

Health and fitness to travel: The client warrants that he/she is healthy and/or fit to participate in The Tour Experience. Tours require a moderate fitness level, requiring ability to walk on cobbled roads and footpaths in Firenze and other cities, steps, footpaths and roads in Sicily & Sardinia, and up some challenging hills in and around Firenze, in towns and on country roads. The most difficult parts are the Cinque Terre walk (in Tour C), particularly for those who would like to walk further than the Manarolo-Riomaggiore segment, and one (optional) walk in Sardegna (Tour A). Hill towns in Italy are in fact hilly. Bedroom accommodation in the country houses/villas is almost entirely on the first (not ground) and, occasionally, second, floor. There are no lifts in villa/agriturismo/country accommodation buildings.
